
According to the Detroit News article, "The National Republican Congressional Committee (NRCC) sent a cautionary and somewhat scathing letter Friday to the cash-strapped Michigan Republican Party, warning the state GOP about its handling of \$263,000 flowing to it through a fundraising operation."

This is the pay back for the refusal of Kristina Karamo to launder money to D.C. Swamp creatures I detailed earlier this week.

This biased reporting by the Detroit News and factually challenged information needs to be examined very carefully! In what appears to be an intentional "setup operation" by the Deep State and the NRCC (National Republican Congressional Committee) has attempted to sabotage the current administration of the Michigan Republican Party.

In the first place you need to understand that the rhetoric stating that the primary job of the Chair of the Michigan Republican Party is to obtain funding for political purposes is a "Myth"!

Historically, MIGOP funding comes from puppet masters that dictate to the Michigan Republican Party what they will receive. As an example, we direct your attention to the chart below.



The vast majority of the money to the Michigan Republican Party (Federal Account) in the last 7 years comes from the RNC and the NRCC. Make no mistake, this money comes with "serious strings" attached!

There are contracts know as Joint Fundraising Agreements that tie the Michigan Republican Party to the NRCC and many other entities. It is understood that acceptance of money is acceptance of taking marching orders on where to spend the money and in turn how candidates will vote.

Breach of this "understanding" will cause the provider of money to stop the flow of these funds that are required to get incumbents re-elected and get new candidates elected to hopefully replace members of the opposite party.

In order to make some sense of the 28,000 contributions to the MRP Federal Account, we filtered out the largest and/or the most influential donors and were shocked to see that the vast majority of money in this controlling group came from the RNC and the NRCC.

In the time frame from Jan 2017 thru June 2023, 97% of the funds of the most significant portion of the funds given to the MRP Federal Account had come from the NRC and the RCCC.

The previous Chairs of the MRP took the money and being good little puppet masters quietly provided the money with the marching orders to our elected "Republicans" in Michigan.

It should be CRYSTAL clear by now should that returning the control of the Deep State (AKA The Uniparty) is NOT the answer!


