**How Did Our Electoral System Break and What Does the “Fix” Look Like?**

Thank you to Colonel Kurt Hyde and all the participants at our first live event held last night. Our guest expert, Colonel Kurt Hyde, provided historical context as to how our electoral system was broken and provided a road map for what a fix looks like. We were additionally blessed with Tim Vetter of [Check My Vote](#) who provided updates on key election integrity tools and projects in Michigan. Many other election integrity leaders participated as well. We will have the video of the event on the website soon and will announce when that is the case!

In summary, here is what we learned:

**How Did the Electoral System Break?**

**Critical point number 1:** The U.S. Election system did not break by accident or by natural causes. Intentional sabotage was involved.

**Critical point number 2:** HAVA is a trap, we must demand it be repealed.

**What Does the “Fix” Look Like?**

**Critical point number 3:** There is a Constitutional Solution found in Article II, Section 1 and in the ninth and tenth amendments.

**Critical point number 4:** The fix includes repeal of HAVA, Repeal of “Motor Voter”, repeal of “early”, mail in, or unexcused absentee voting, use of paper ballots that are both cast and counted in public view at the precinct level with posted results at every precinct.



**Col. Kurt Hyde Demonstrated How this Photo was a FRAUD**

Images like the above photo were used to instill in Americans an emotional reaction to the “hanging chad” issue in Florida during the 2000 election. That reaction was what fueled the need for a “solution”. And just like the Patriot Act was a “solution” to 9/11, HAVA was the “solution” to “hanging chads” and other oddities from the 2000 election.



In essence it was a “Deer Drive” on election law. The “Problem” was artificially created so that people would be driven to demand a “solution”. Turns out that “solution” we were driven into was a in fact a globalist holding a tag that says “U.S. Election Law”.

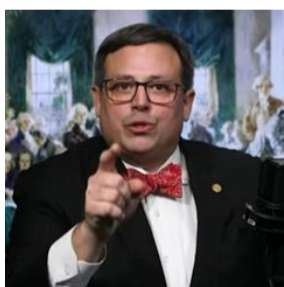
