
Dear Friend,

## MIGOP Chair (1983 to Current)

**Former MIGOP Chair Spencer Abraham** (1983-1991): Used connections and dirty money to bribe his way into the U.S. Senate. Later served as Sec. of Energy, currently serves on the [U.S. Global Leadership Council](#). As Senator, Abraham championed the passage of H.R. 4444 (Passed by Senate on 9/19/2000). H.R. 4444, granted [Communist China Permanent Normal Trade Relations \(PNTR\)](#), and thereby abolished the annual review process of Chinese Trade. It **solidified Chinese entry into the World Trade Organization**. The bill assured that the tyrannical Chinese government will continue to receive billions of dollars in U.S. taxpayer-subsidized trade annually through export subsidy programs such as the [Export-Import Bank](#) and multilateral organs such as the [Asian Development Bank](#) and the [World Bank](#).



Worse yet, **Abraham** was so cold blooded as to vote to **turn a blind eye to blatant human rights violations by China**. On 9/12/2000 he [voted against](#) an amendment to H.R. 4444 that "directs the President to certify that China has met a series of human rights conditions prior to granting PNTR to Communist China." The amendment would prohibit the granting of "free trade" privileges to China under Permanent Normal Trade Relations (PNTR) until China has abolished the Laogai prison-labor system and released all religious prisoners and labor leaders.



As you might expect, **Abraham was your typical free spending Washington swamp creature**. An example of his blatant unconstitutional spending includes an omnibus spending bill he voted for on 6/30/2000 (H.R. 4577), a Welfare State Mother Lode. The Senate version was billions more expensive than the House version. This \$351.8 billion fiscal 2001 Labor/HHS/Education appropriations bill represents a spending increase of more than seven percent over fiscal 2000. Representative David Obey (D-WI) crowed that Republicans and Democrats were in a bidding war for welfare state spending.

**Spencer Abraham** was a leader in the passage of H.R. 3194 on 11/19/99 that gave the **United Nations** nearly **\$1 Billion dollars** for “arrearages”.

**Former MIGOP Chair David Doyle** (1991-1995): President of D2 Strategy & Research LLC; long history in state, national and global politics; one of 300 Republicans who signed an amicus brief asking the United States Supreme Court to legalize same-sex marriage nationwide. Serves as a “Russian Ambassador” for the globalist International Republican Institute: Welcome to IRI


**Former MIGOP Chair Betsy (Prince) DeVos** (1996-2000; 2003-2005): billionaire married into the DeVos family. Daughter of billionaire Edgar Prince. Brother Eric Prince was the founder of Blackwater. **Betsy DeVos famously betrayed Donald Trump in the aftermath of January 6 and maintains that Joe Biden won the election.** The globalist connections are so significant here, we will save it all for its own special issue. But the verdict is clear on this one.

**Former MIGOP Chair Gerald “Rusty” Hills** (2000-2003): advisor to Bill Schuette, chief lieutenant for John Engler, helped globalist Spencer Abraham re-engineer the Michigan Republican Party. “Rusty” was more of a reliable henchman than an actual architect, however he was a key asset in assisting Engler obtain re-authorization of the Import-Export Bank and implementation of globalist programs into commerce and industry via the Business Roundtable.

**Former Chair Bobby Schostak** (2011-2015): Born into the Schostak Brothers & Company real estate dynasty, founder of the national political strategy firm Templar Baker Group "TBG", with close ties to Dick DeVos and Ron Weiser. TBG is hard wired into the Military Industrial Complex though relationships with Mike Rogers and his group "America for Peace, prosperity & Security which is bankrolled openly by Rand, General Dynamics and others. **Former MIGOP Chair Ronna Romney McDaniel** (2015-2017): part of the Romney oligarchy, under her RNC tenure, the RNC met with and took money from the Chinese Communist Party to discuss "campaign strategy" at the U.S. China High Level Political Party Leaders Dialogue, a conference held in Beijing. McDaniel was just recently forced to resign as Chair of the RNC in significant part as a result of her betrayal of Kristina Karamo, the current Chair of MIGOP.

**Former MIGOP Chair Laura Cox** (2019-2021): Michigan House Rep for 2014-2018 with poor voting record. Despite public protestations of election fraud in the 2020 election, Cox did virtually nothing to utilize the tools available to MIGOP to obtain evidence and prosecute election fraud. Cox was either epically incompetent or a willing participant in Biden stealing the election in Michigan.

**Former MIGOP Chair Ron Weiser** (2009-2011, 2017-2019, 2021-2023) serves on the U.S. Global Leadership Council and the Atlantic Council, an arm of the United Nations. Oversaw the most complete, thorough beat down of the Republican Party in 40 years. So completely destroyed the Republican brand that over 90% of all funding came from a small handful of donors. Transferred \$1.9 Million out of MIGOP the last day in office to leave it a smoking hole in the ground with hundreds of thousands in debt and zero assets.

## **Current MIGOP Chair Kristina Karamo (2023- )**

Kristina Karamo is a lifelong Michigan Republican Party activist that was initially sparked into action in the pro life movement. With a degree in Christian Apologetics, Kristina never aspired to political office of any type. She was present at the Detroit TCF and witnessed the theft of the 2020 presidential election go down right before her eyes. Kristina ran for Secretary of State in 2002, out fundraising every Republican to have ever run for Secretary of State in Michigan by a long shot. In 2023 Kristina Karamo was overwhelmingly elected as MIGOP chair from the thousands of delegates gathered at the MIGOP Convention. Kristina was elected not because she was a billionaire or because she had the connections to continue to use MIGOP as a money laundering machine for the globalists, Kristina was elected because the delegates knew she had the strength and integrity to deliver. Indeed Kristina has delivered!

As proof, let's inspect the "fruit" offered from Kristina Karamo:

5. Successfully defended the number of delegates allotted to Michigan at the 2024 RNC National Conference after the Democrats in Lansing changed the Primary election date and triggered a penalty clause in the RNC rules.

7. Held a Health Freedom Town Hall with U.S. Senator Ron Johnson to honor those that "Will NOT Comply!"
