THE GRAND JURY CHARGES:			
GENERAL ALLEGATIONS			
1. At all times relevant to this Indictment, LASON, INC. ("Lason") was a			
Delaware corporation with its headquarters in Troy, Michigan. Among other things,			
Lason was engaged in the business of information management, which primarily			
involved document and data capture, data management through electronic storage			
and retrieval, and the output of information digitally or in print. Lason had dozens of			
operating units located throughout the United States and in other countries, and			
served hundreds of business customers, including automobile manufacturers.
