



Dear Friend,

Malinda Pego was right about one thing. John Yob and his attack dog **Warren Carpenter** are indeed “**thugs.**” (Quote taken from a secretly recorded admission made by Pego immediately before her forced resignation as County Chair). Recall that bribery, fraud, extortion and conspiracy are John Yob's calling card and preferred method of operation. This was his “go to” method when he successfully engineered a take down of a grassroots GOP Chair in his new home in the U.S. Virgin Islands. The secretly recorded audio tape is a 17-minute phone conversation between former secretary of the V.I. Republican Party Robert Max Schanfarber and John Yob

political operative Dennis Lennox. On the tape, recorded in Washington, D.C., Lennox explicitly states arrest records will be revealed if Schanfarber does not cooperate and the same records will “disappear” if he does as directed.


Additionally, Lennox promises Schanfarber that if he cooperates with Yob to take down the current USVI GOP chair and install Yob’s selected favorite Gordon Ackley, then he will be **cut in on financial deals** and Lennox **even promises to deliver photo ops with Donald Trump.**

“**Max I know about your arrest records in California,**” Lennox says on the tape. “**What arrest records in California, I don’t have any arrest records in California,**” Schanfarber responds.

Lennox: “**In multiple counties, in the 1980s. ... I have all the records Max. I have them from all the counties. So what I am telling you is right now I would like to make a deal with you. I’m offering you the opportunity to support John Yob, Gordon Ackley, Jevon, Antoinette, April, unify the party, those records will disappear and never show up again. All you have to do is get on the right side of history and side with the RNC.**”

Back to the present and the chaos that Yob has created at MIGOP, here are some of the exhibits that will be used at their criminal trial.

A text message sent by Warren Carpenter to try and force a State Central Committee member to agree to betray Kristina Karamo, inclusive of **bribery attempts** and **extortion threats**.



When the bribery and extortion efforts failed, Warren Carpenter showed his true self in this **ugly voicemail left on January 5, 2024:**

I can't wait for the day that you try to run for anything. And I'm gonna make sure that everybody knows across the entire fucking state that you stood by and you did absolutely nothing. And you're a coward. You are, uh. You are a weak coward. I am so furious with you right now. You know better than this. You will never hold a single office anywhere, anywhere in your life again. I will make it my personal mission to run against you in any place you do anything knowing what you know, being on the budget committee and then making these bullshit arguments the way that you have. And I hope that you share this with everybody, because I'm coming. I cannot believe you. Again, anything that you try to run for, I will make sure that you don't get over the finish line. I will make it my life's mission to work against you in anything that you put your name forward towards.


The day before the Coup Crew's fake meeting on January 6, Warren Carpenter ADMITS key problems:

Yob doesn't have the correct numbers on the petition to remove Karamo

Yob doesn't have the numbers to make quorum (ever with proxies) Jan. 6

Yob's plan has been in development for many months

Here is the text message with those admissions:



Fortunately for **Yob, Carpenter** and their co-conspirators, **the same guy that consulted with them on how to commit conspiracy and fraud can also give them tips on prison living.**

William Rauwerdink was sentenced to three years and nine months in prison and ordered to pay \$285 million in restitution after he plead guilty to conspiracy and false statements in a federal indictment related to his role as a chief financial officer. He was also sentenced to two years of supervised release following prison.
