



In all of these cases Mauger had specific knowledge that his “witness” was severely compromised but actively hid that fact and referred to him as a “businessman.” The reality is that Carpenter is as much a “businessman” as a hooker is a “missionary.” Yet Mauger continually ran down Kristina Karamo and her administration at every pass without taking even minimal steps to verify the information with credible sources.

Our second example is more recent. The Michigan Gop Red PAC event that Hoaxtra help in Grand Rapids was a dismal failure in terms of attendance. It was the lowest attended convention of its type in recorded history. There were more people gathered in a few local congressional district meetings than the entirety of the Grand Rapids PAC meeting from the state combined.

But Mauger needed to be an apologist for Hoaxtra and build up the interest to make him seem more legitimate. Mauger knows that Hoaxtra is a globalist tool and he appreciates that shilling for him will earn him the brownie points he needs to get out of the provincial wasteland (in terms of legacy media) and make it big. Accordingly, we see him respond to my exposure of the truth with lies to bolster Pete.

A lot of empty seats indeed! That was the story of the Grand Rapids event, a lot of empty seats.

One of the few people that did show was none other than former MIGOP executive director Paul Cordes.

On behalf of MIGOP, Paul Cordes signed a \$3 Million dollar debt with CO-America of which \$900,000 was outstanding. **This resulted in MIGOP being hundreds of thousands of dollars in debt on Day 1 of Kristina's administration.**

The most shocking aspect of this is that the note signed by Paul was authorized by a fake resolution of the state committee. The document was signed by the officers but had no signature of the Secretary and was not the result of a state committee meeting as it declared on its face. This debt was also supported by a negative pledge of the MIGOP building.

Per Paul Cordes, the computer server with all financial and fundraising records was the private property of a former chair who said Karamo could not have access because the party did not own its data it was in a trust and Karamo was not permitted access.

After Co-America brought a collection case against MIGOP, we also learned that the Michigan Republican party was the ransacked by the prior administration who put the building and any asset of value out of reach from anyone that would take over the part for Pro-American causes.

In summation, Paul Cordes was the primary person responsible to make sure that when Kristina Karamo took over, she would get nothing but a smoldering hole in the ground.

Many still on State Central Committee can recall participating in official state committee phone call meetings run by the prior administration in which the state committee voted by telephone in a virtual meeting—not Zoom. Multiple people reported that it worked like this: Votes were taken by pushing buttons on the phone keypad 1 for yes, 2 for no, and 3 to abstain.

During the administration transition, Dan Hartman asked Paul how the phone voting system worked exactly. Paul Cordes laughed in his face and said there is no system and never was, the committee just pushed buttons and the Weiser team just made up the results of the votes taken. Paul thought it was funny that the state committee members were gullible and trusting that their vote mattered.

During such time as the appeal runs, not one penny should go to MIGOP nor one moment of your time. It should be considered as a leper camp to be shunned and avoided.

There is however much to do and being organized as a team not under the thumb of Hoaxtra is important. Accordingly, consider if you agree


