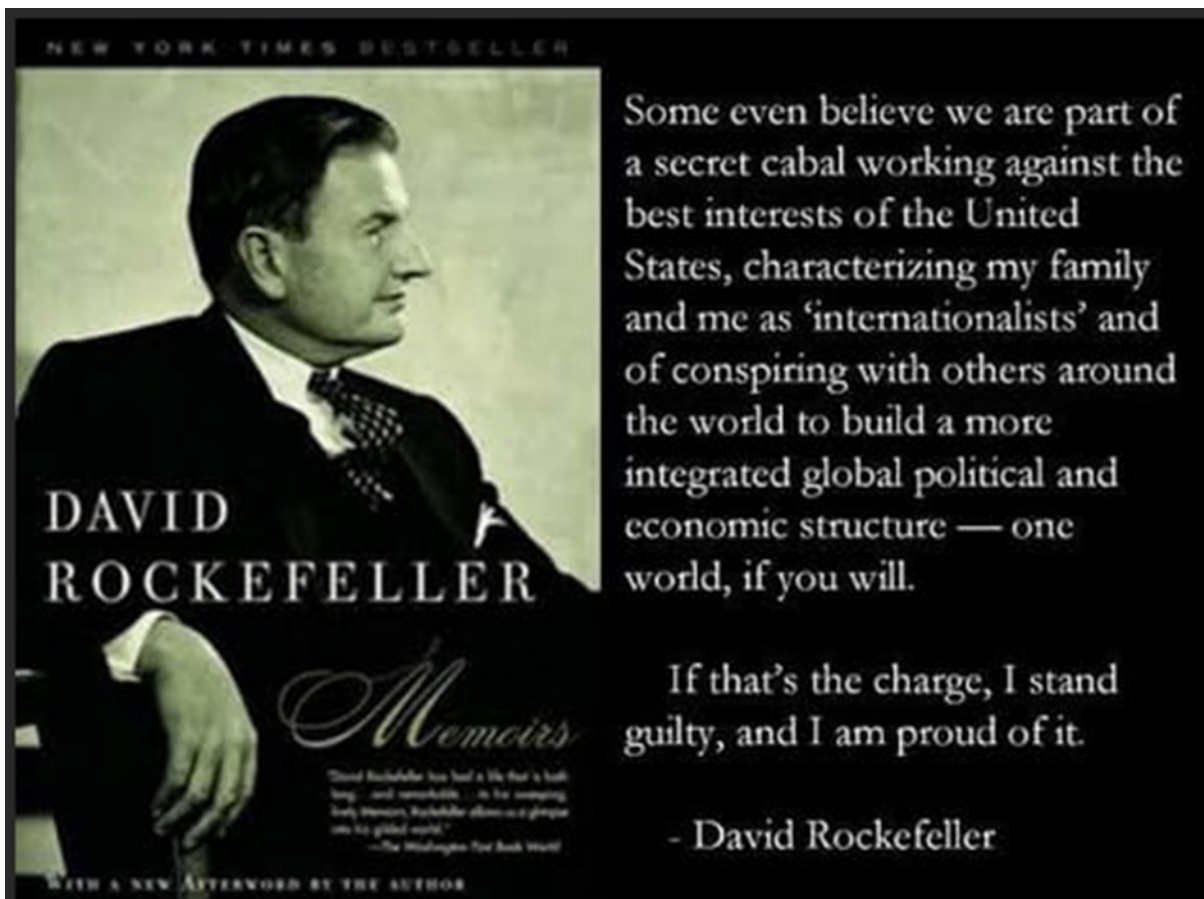
money before the primary season to make sure they can kill off anyone that would reject the Council on Foreign Relations.
