



Dear Friend,

Let's be clear what this fight over the MIGOP Chair position is all about.

It's about power and money.

Who should hold the power of MIGOP?

The Grassroots or the Donor Class?

Should MIGOP be used to perpetuate swamp creature politics by continually laundering money for the globalist compliant political class?

The current situation is a direct retribution of Kristina Karamo's refusal to launder money for the globalist aligned swamp creatures in Washington. To be clear, John Yob and the Donor class in the Michigan Republican Party have been plotting to take Kristina Karamo out since the moment she won the MIGOP Chair election in February last year. But they needed an inside source in the RNC to feel comfortable in attempting the coup. **Once the globalist aligned members of the RNC and NRCC realized that Kristina Karamo would not launder money from, they gave Yob and his minions the green light.**

A quick refresher on my money laundering claims above.

Last year, the National Republican Congressional Committee (NRCC) entered into a fundraising agreement with MIGOP which was to permit MIGOP to support Congressional Candidates in Michigan. The agreement was that the NRCC could not put "strings" on the money. Once they gave it, it was up to MIGOP to allocate the resources. Here are the critical parts of the agreement:

JOINT FUNDRAISING AGREEMENT

This Joint Fundraising Agreement ("Agreement") is made and entered into within the District of Columbia on this 18th day of January, 2023, by and between

1. Kevin McCarthy for Congress (C00420935);
2. Majority Committee PAC—Mc PAC (C00428052);
3. NRCC (C00075820);
4. Congressional Leadership Fund (Contribution Account) (C00504530);

This is the specific language that prohibits "strings" attached to the donations.

- I. The Committees specifically agree that each Committee's share of net proceeds is not earmarked for any particular candidate or use and that each Committee shall use its share of net proceeds in its sole discretion.

The Michigan Republican Party was specifically included in the plan on those terms.

And the idea that strings cannot be attached to donations of this type is in observation of specific Michigan law on the subject.

**MICHIGAN CAMPAIGN FINANCE ACT (EXCERPT)
Act 388 of 1976**

169.244 Prohibited contributions or expenditures; delivery or return of contribution; joint fund-raiser; violation as misdemeanor; penalty.

Sec. 44.

(1) A person shall not make a contribution to another person with the agreement or arrangement that the person receiving the contribution will then transfer that contribution to a particular candidate committee.

Yet it was Kristina Karamo's REFUSAL to give \$250,000 as specifically directed by the NRCC to one candidate who happened to have a terrible voting record and was in jeopardy of being subject to a primary from an actual conservative that triggered the green light for Yob and crew.

The RNC and NRCC are accustomed to State Party Chairs that will simply take orders and process the checks. Kristina Karamo refused to participate in the scheme. Kristina Karamo will not be bullied, will not be bribed and will not violate the law to perpetuate swamp politics that has consistently destroyed our nation like a cancer from within.

The people at the RNC and NRCC are simply lawless. And for their agreement to work with Yob to take out Kristina, they demanded that they get to name a new replacement. This is where Peter Hoaxtra and Mike Bishop come into play. **They are both former congressmen experienced in taking a river of dirty money funneled through the NRCC and thus can be relied upon to violate the law without reservation.** They have NOT been otherwise engaged in MIGOP business in any way for a considerable amount of time.
