### **Peter Navaro is a Political Prisoner**

Peter Navaro reported to FCI Miami yesterday to begin serving a four-month sentence for contempt of Congress. Navaro served as White House trade advisor to former President Donald Trump, and was subpoenaed by the January 6th Committee. Navaro ignored the subpoenas and claimed that he was exempt from the subpoenas due to Trump asserting executive privilege on his behalf.

Supreme Court Chief Justice John Roberts denied Navaro's appeal, claiming that he should have showed up for limited questioning. This is of course a farce and Justice Roberts continues to show his Obamacare like roots of liberalism. In denying the appeal, Roberts wrote in the order: "The application for release pending appeal under 18 U. S. C. §3143(b) is denied. This application concerns only the question whether the applicant, Peter Navaro, has met his burden to establish his entitlement to relief under the Bail Reform Act. The Court of Appeals disposed of the proceeding on the ground that Navaro "forfeited" any argument in this release proceeding challenging the District Court's conclusion that "executive privilege was not invoked," "forfeited any challenge" to the conclusion that relief would not be required in any event because of the qualified nature of executive privilege, and "forfeited any challenge" to the conclusion that apart from executive privilege, he was still obligated to appear before Congress and answer questions seeking information outside the scope of the asserted privilege. Order in No. 24-3006 (DC, Mar. 14, 2024). I see no basis to disagree with the determination that Navaro forfeited those arguments in the release proceeding, which is distinct from his pending appeal on the merits."

Navaro spoke to reporters before reporting to FCI Miami, stating, "If they can put me in prison, they can put you in prison. Make no mistake about that, and make no mistake about this, they're coming after Donald Trump with the same tactics, tools, and strategies they used to put me over there today."

### **Lambert & Carpenter: Two Types of "Justice"**

Michigan attorney Stefanie Lambert was arrested in Washington, D.C., following a court hearing after she gave evidence of election fraud to law enforcement.

Lambert attended a court hearing in Washington, D.C., for a defamation case involving Patrick Byrne, whom she represents. Byrne, the former CEO of Overstock, is being sued over his claims of election fraud.

Lambert's arrest occurred after it was revealed that she had leaked confidential documents Barry County Sheriff Dar Leaf, who has been actively investigating claims of voter fraud from the 2020 election.

Barry County Sheriff Dar Leaf then sent a letter to U.S. Representative Jim Jordan, Chairman of the Judiciary Committee, urging a congressional investigation into what he alleges is evidence of "foreign interference" in the 2020 election.

**One of the strongly contested issues in the election fraud claims is that the voting machines had internet connectivity and could thus be manipulated.** Dominion has strongly claimed that there was no connectivity or even potential of connectivity.

**Subject:** AK ICP modems failing acceptance testing

Just heard from Bill Mast. It appears that only 34 of the ICP model 321C units shipped to Alaska were manufactured with the modem. The team calls those "natural" ICP 321 C. Twenty of the "natural" ICP 321C units were shipped to Region 1 – Juneau and all 20 have passed the modem test. The remaining 14 units are located in other Regional offices and acceptance testing has not begun in those locations

The remaining 304 in Alaska were retrofitted with dial up modems and received in all five regional offices. As of today none of the retrofitted ICPs in Region1 have passed acceptance testing. Acceptance testing is to continue in Anchorage, and the other regions next week.

Jeff Hintz reported yesterday that McKinney had not done any modem testing prior to shipping the units to Alaska.

We need to find out why the modems aren't working, make arrangements to get techs to Alaska to fix the problem ASAP. The statewide mock election is scheduled the week of February 10<sup>th</sup> and includes dial up modem transmissions from the regional offices and random rural locations.

Bill has created JIRA BSR tickets this afternoon, once we received the spreadsheets identifying the units that had been retrofit.

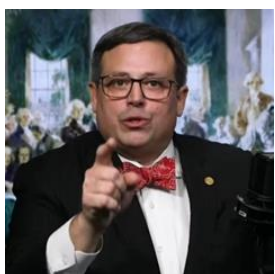
