### **MRP State Director Lori Skibo Defeats Peter Hoekstra**

In early 2024, the Michigan republican Party (MIGOP) faced a highly publicized leadership dispute arising out of competing claims to the chairmanship between Kristina Karamo and Peter Hoekstra. Utilizing connections with the law firm of Warner Norcross and Judd, a notorious globalist aligned law firm that gets paid millions of dollars by the international elite to marginalize patriots and promote controlled opposition, Hoekstra was able to payoff/bribe/threaten Judge Rossi in Kent county Michigan to rule in Hoekstra's favor. (It is noteworthy that Warner Norcross law firm represents both the national Republican Party and the national Libertarian party. As a result you can assure both are severely compromised.) That decision has been rejected in other courts, is on appeal, and is expected to be overturned any moment.

During this brief interim in which the usurper Peter Hoekstra has been in charge, he has led the specific purge effort to marginalize and remove all grassroots patriots that would object to his clearly inevitable plan to betray Trump and betray the election integrity movement in every possible way.

Chiefly among Peter Hoekstra's targets was MRP state director Lori Skibo. Lori is a well respected and longtime member of the Republican state central committee and has tirelessly committed herself to the advancement of Americanism. When volunteers were needed Lori was the first to raise her hand. When donors were needed, Lori was the first to write a check. This is not to say that she has vacation homes and yachts in the Caribbean like other Michigan establishment political insiders, for she is a normal person just like the rest of us. It just so happens that Lori values and prioritizes freedom, and she walks the walk while others just talk and talk.

Peter Hoekstra illegally had Lori Skibo removed as a national delegate for Congressional District nine of the Republican Party of Michigan. This illegal action was intended to have the dual benefit of both removing Lori and allowing Mark Forton onto the state committee as a sort of permanent proxy as political payoff for Mark's betrayal of MIGOP Chair Kristina Karamo.

Peter Hoekstra had initial success with his schemes and machinations to fraudulently steal the Michigan Republican Party. However, facts and truth are catching up with him and the wheels are coming off his snake oil sales cart.

First, courts are already rejecting the legal theory by which Hoekstra took power over Karamo. That legal edict against Hoekstra has already been issued in Kalamazoo and will soon be followed in Kent County and is also the subject of federal litigation.

**Long story very short, Peter Huckster is a short timer and he should pack up his desk now.**

Peter Hoekstra's losses continued on June 28 of this year. On that day, **the RNC committee in charge of national delegates issued a ruling in Lori Skibo's favor and against Peter Hoekstra's political larceny team.** Whereas previously Peter was able to use his connections at Warner Norcross and their involvement in the RNC to engineer a bribe to pay off RNC officials to allow him to claim the chairmanship, a different committee was established in this case in which he did not have sufficient connections to put his globalist backed thumb on the scales of justice.

Kristina Karamo is the rightful Chair of the Michigan Republican Party. In short order the usurpers will be thrown out. The sooner that happens, the sooner we can actually do something about election integrity.

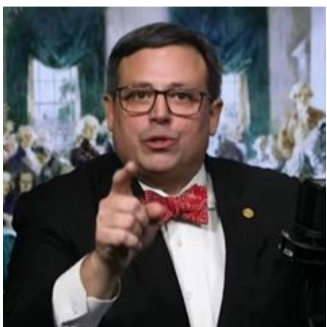
