this time and recorded three segments of conversation. These three files were added to property in this case. For the full contents of the files, review the files.

I spoke with [REDACTED] via video chat. He identified himself as [REDACTED]. I observed a middle-aged black male with a medium build on [REDACTED] phone/video chat screen. I asked him what [REDACTED] was. He stated [REDACTED] is an "operations firm that helps out around campaigns. We are an operations team and we go out in the field and we knock on doors during campaigns. We send people into the community and they knock on doors uh to engage educate and mobilize the community around different elections." I went on to ask [REDACTED] if he was currently in Michigan and he stated he is not, he is in Iowa. [REDACTED] asked to see a copy of the search warrant and I told her I would give her a copy when I get her name and her role in the company. As soon as I obtained her name I provided her a copy of the initial search warrant. This occurred soon after the first conversation with [REDACTED] ended. I also heard [REDACTED] telling [REDACTED] that she needed to make sure she declared the personal items he left behind before leaving the state. It should be noted it was later found that he was referring to multiple firearms and ammunition within one of their suites as noted in D/F/Lt. Anderson's report.

While waiting for the updated search warrant a few more employees from [REDACTED] arrived on scene and were asked to come into the training room to avoid going into the secured area we had cleared. All of them were cooperative with this request. Also during that time 2nd District SIS MSP employees D/Lt. Richard Sanchez, along with Detective Troopers Chang, Pirvu, and Terrill arrived to assist. They interviewed those present who were willing to be interviewed. See their reports for content of the interviews. D/Tpr. Pirvu interviewed employee [REDACTED] completed a written statement which was placed in external documents. D/Tpr. Chang interviewed employee [REDACTED] and documented the interview in her original report. D/Tpr. Terrill interviewed [REDACTED] and documented the interview in a supplemental report to D/Tpr. Chang's original report. I asked [REDACTED] if she was willing to be interviewed and she declined stating she did not want to talk further without consulting with a lawyer.

Also, while waiting for the amended search warrant [REDACTED] approached me and stated the attorney for [REDACTED] wanted to speak with me. His name was Brian Lennon and he was with the law firm Warner Norcross & Judd. Brian gave me his cell phone number which was [REDACTED]. Brian stated his firm was being retained by [REDACTED] for this investigation and he had just spoken with someone from [REDACTED] in Atlanta about being retained as outside counsel for this case. Brian stated [REDACTED] would be fully cooperative and wanted to give investigators whatever they needed to do their investigation. Brian asked me if we would be seizing hardware from the rented space as part of this investigation. I told him I presumed we would but did not know how much we would take at that time. I obtained his cell phone number and then called him after clearing the scene that evening, telling him a synopsis of what we had seized.

EXECUTE AMENDED SEARCH WARRANT:

The amended search warrant was received electronically by me from D/F/Lt. Anderson at 3:22PM. The search of the premises occurred after that time. The search was conducted by MSP personnel present. I completed the tabulation/return. At the conclusion of the search warrant I gave a copy of the tabulation to D/F/Lt. Anderson. The 2nd District SIS generated a complaint number for the assistance they provided and they will document their interviews and other search/scene/surveillance efforts in that report. Their complaint number is: SIS-295-20. All property items were turned over to D/F/Lt. Anderson after tabulation was complete.

Affidavit of Grant Golasa


Grant Golasa, being sworn under penalty of perjury state the following:

1. I am a state committee member elected from Macomb County in the 10th Congressional District.
2. I was contacted repeatedly by Warren Carpenter who was seeking my support by seeking my signature on the petition for a vote on the removal.
3. I am familiar with Warren Carpenter and know it to be his voice on these calls.
4. The petition was presented not as a vote for removal but rather as a vote to settle the dispute.
5. I was offered in writing via text, "I'll make a promise...if you run for anything in the future I will personally get you past the primary...this is a promise." in order to persuade me to sign the petition which I interpreted as an attempt to bribe me.
6. After refusing to sign the petition, I was told by Warren Carpenter on a voicemail,


"I can't wait for the day that you try to run for anything. I'm gonna make sure that everybody knows this the entire fucking state that you stood by and you did absolutely nothing. You are a coward. You are a weak coward. I'm so furious with you right now. You know better than this. You'll never hold a single office anywhere anywhere in your life again. 7. In one conversation during the time he sought my signature, I was told that the removal had beenplanned including the drafting of the lawsuit.....During the phone call with a man purporting to be Troy Cummings.
8. I recorded my phone calls with Warren Carpenter as a party to the conversation.
9. I turned over copies of the recordings to MIGOP on January 28, 2024.

Warren Carpenter is still a fugitive from the law to this day!

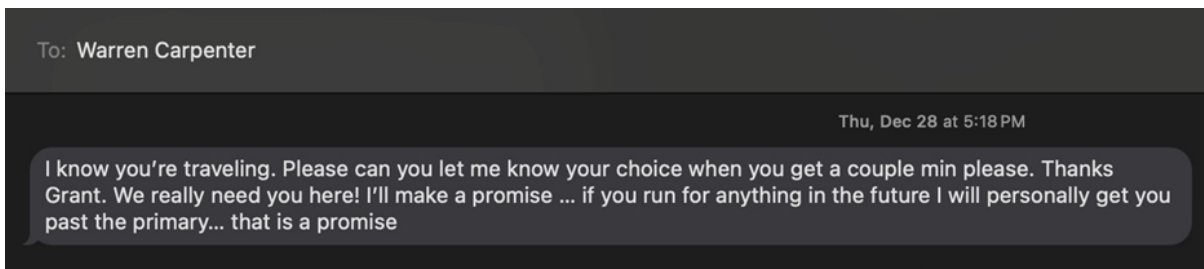

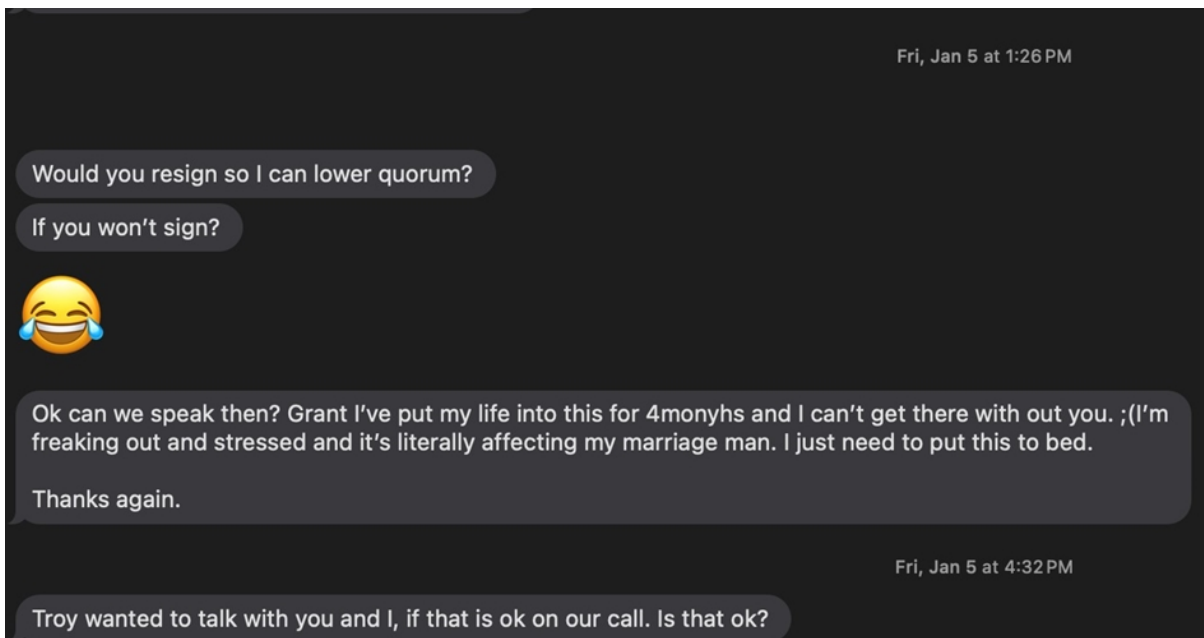

And I hope that you share this with everybody, because I'm coming. I cannot believe you. Again, anything that you try to run for, I will make sure that you don't get over the finish line. It should be noted that while Carpenter was trying to obtain Mr. Golasa's support, he specifically attempted to bribe him. This was a text message that Carpenter sent to Golasa on December 28, 2023:

We see from a text he sent just the afternoon prior where he admitted to this fact with the statement **"I can't get there with [sic] out you."** (Also note that the 4:32pm reference to "Troy" does in fact identify Troy Cummings and we have the complete audio of that call).
