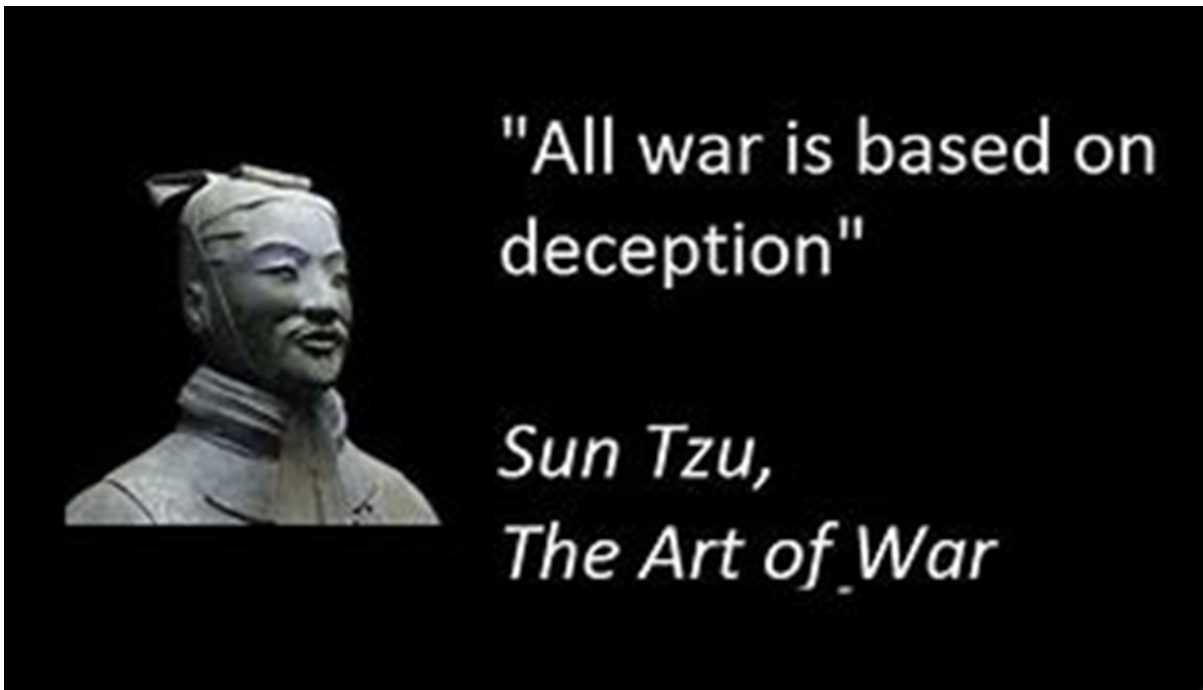




Dear Friend,

Malinda and her gang answer to John Yob. This is John Yob:



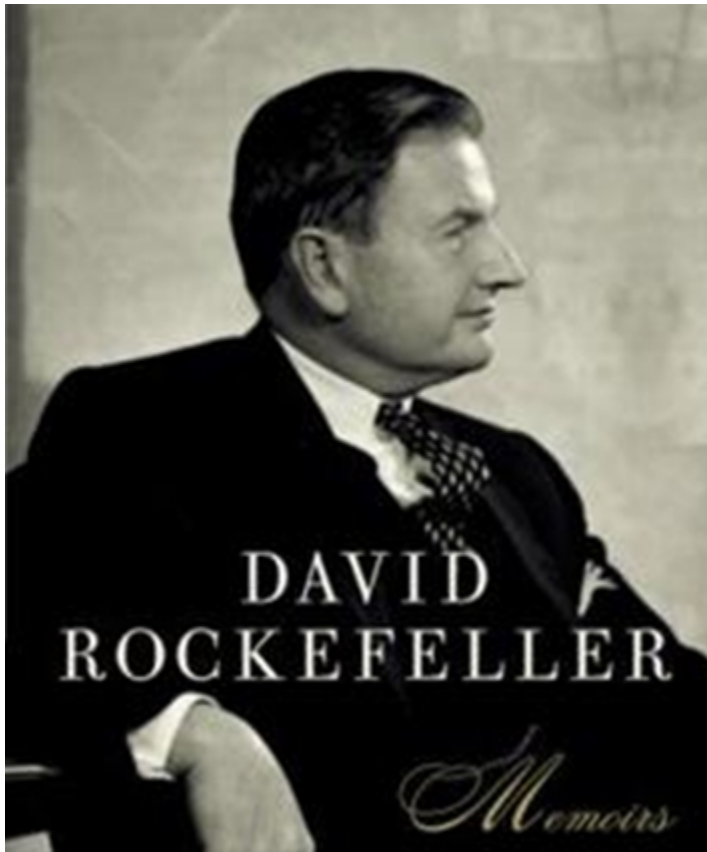

The meeting on January 13 is a definite go and will not be cancelled!

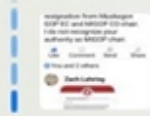

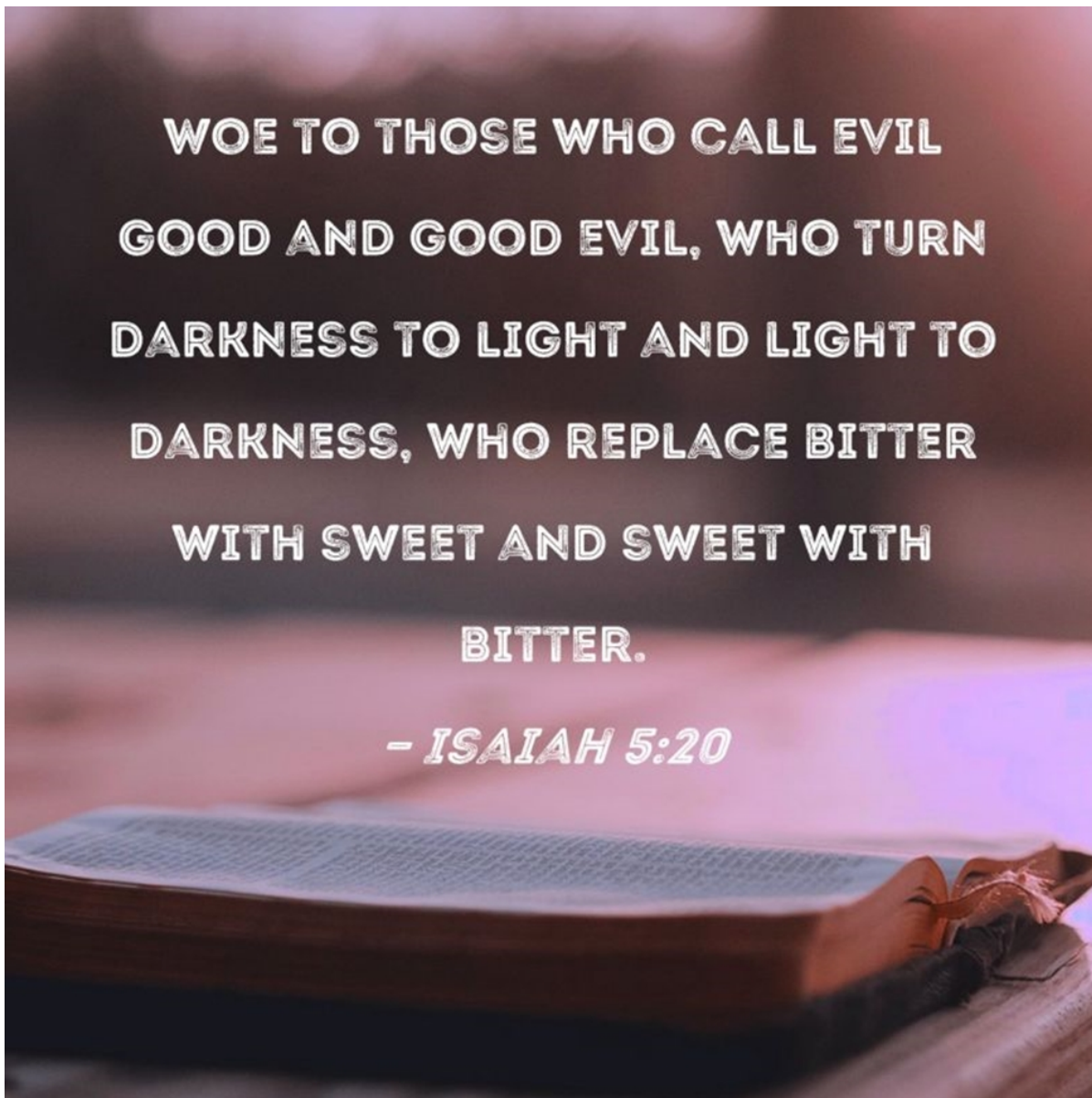
