Today is February 16, 2024.

Kristina Karamo is the Chair of the Michigan Republican Party.

In fact, reports from all over the state from Republican Party County Conventions held on February 15 indicate an overwhelming pro Kristina Karamo result. **In most counties a slate of 100% pro Kristina Karamo delegates were elevated to State Convention quickly and with no fuss.**

In Oakland County, where January 6 Coup Planner Vance Patrick is County Chair, **Kristina Karamo arrived and received a standing ovation!** Patrick tried to push through a slate of Hoaxtra supporters but despite his best effort the best he could manage was a half loaf for Hoaxtra. Vance's failure to deliver was most noted by his vice chair Terri Nallamothu (so smug during the January 6 Coup) who was rebuffed and she does not get to go to state Convention as a delegate. So sad.

These are typical of the results that played out statewide. In 80% of the Counties in Michigan, last night was a quiet affair devoid of drama but full of support for Kristina. In a handful of counties where Hoaxtra’s clan held leadership positions, they were able to game the system to get a 50/50 split between Karamo and Hoaxtra supporters. In Macomb County, the meeting lasted past 1a with Hoaxtra people in charge but they were only able to get a handful of Hoaxtra supporters through to State Convention as the once popular Mark Forton has watched his reputation continue to go into the trash can as he now cavorts with the likes of Stan Grot: Secret payment of \$200K to Shelby Twp. This is important because at the state convention **Kristina Karamo will give the delegates a choice and put the leadership to a vote again.** Hoekstra is terrified of this because he does not have the votes and he knows it. Beyond simply fraud, what he is doing has a specific name to it. **It's called Gaslighting.**

### Gaslighting

Gaslighting is a tactic in which a person or entity, in order to gain more power, makes a victim question their reality. It works much better than you may think. Anyone is susceptible to gaslighting, and it is a common technique of abusers, dictators, narcissists, and cult leaders.



Let's be sure we understand what this fight is all about.

Kristina Karamo is a powerful Christian woman whom God led to the Detroit TCF center to personally witness the election fraud in 2020. Kristina sees it as a personal calling in life to ensure that the 2024 election is not stolen. She has rejected bribery attempts. She has refused to back down to extortion threats. She is resolute in her mission despite impossible challenges.

In contrast, Peter Hoekstra is a career Washington swamp creature who has processed a river of dirty money during his lifetime in service to globalists at the Council on Foreign relations and World Economic Forum.

Now comes Heath Wall:

1. I am the current Chairman of the Michigan Republican Party ("MIGOP") Policy Committee. I am in good standing, and I have not been subject to any removal actions by the Peter Hoekstra group. I was in good standing and served as Chairman of the Policy Committee at all times relevant to the inquiry at hand.
2. As MIGOP Policy Chair, my committee has exclusive responsibility for originating all policy, procedure, by-laws, rules, and other such documents that outline how the Michigan Republican State Party is organized and regulates itself. As MIGOP Policy chair, I created sub-committees for the delegation of work. One such sub-committee is a by-laws sub-committee.
3. The bylaws subcommittee was given responsibility on behalf of the State Central Committee to investigate the legitimacy of the January 6, 2024 meeting of select State Central Committee members.
4. The findings of the sub-committee (attached hereto as Exhibit A) concluded that the purported actions of the said select group of members on January 6 were null and void as to any claim to have altered bylaws or removed Kristina Karamo as Chair of MIGOP.
5. On January 13, 2024, the full State Central Committee met and approved the sub-committee report attached hereto as Exhibit A.
