



Dear Friend,

Thank you for the response we have received at [info@puregrassroots.org](mailto:info@puregrassroots.org). Please keep e-mailing me! The vast amount of information we have received about John Yob and his operations over the last two weeks has been helpful as **we have continued to expose Yob** as the financial mastermind and ringleader behind the January 6 Coup Crew in Commerce.

Beyond the obvious mix of responses such as "Your e-mails are just epic! Keep it up!" and "F@\*k You! Die Scumbag!", there have been insightful questions.

A good question from Jennifer in Lansing is **"What is John Yob's motive?"**

William in Detroit asks, **"Has John Yob ever done anything like this before?"**

Good questions!

#### **"What is John Yob's motive?"**

**John Yob is a diehard Never-Trumper.** His goal is to make sure that Trump fails in Michigan. **His plan is to create chaos at MIGOP that will serve as a cover for election fraud in 2024, much like the plandemic was used as cover in 2020.**

Once the election is stolen, the media will spin the story that the loss was a result of disfunction at MIGOP as the election itself was the "fairest election in the recorded history of all elections" or some such nonsense.

#### **"Has John Yob ever done anything like the Michigan Coup before?"**

**Before John Yob began the current coup operation in Michigan, he gave his methods a rehearsal in the U.S. Virgin Islands.** In 2016 Yob began running a virtually identical insurgency campaign against USVI GOP Chairman John Canegata. **Using proxies, frontmen and bribes, Yob successfully took Chairman Canegata down and replaced him with a puppet named Gordon Ackley.** The sorted details are described in January 27, 2021 article published in the St. Thomas Source detailing just one of the bribery programs run by Yob:

A tape of a 17-minute phone conversation between former secretary of the V.I. Republican Party Robert Max Schanfarber and political operative Dennis Lennox has been alleged to highlight unethical dealings among party officials. On the tape, recorded in Washington, D.C., last fall, Lennox explicitly states arrest records will be revealed if Schanfarber does not cooperate and the same records will "disappear" if he does as directed. There is also talk of the signing of deals and even photo ops with the president of the United States.

"Max I know about your arrest records in California," Lennox says on the tape.

"What arrest records in California, I don't have any arrest records in California," Schanfarber responds.

Lennox: "In multiple counties, in the 1980s. ... I have all the records Max. I have them from all the counties. So what I am telling you is right now I would like to make a deal with you. I'm offering you the opportunity to support John Yob, Gordon Ackley, Jevon, Antoinette, April, unify the party, those records will disappear and never show up again. All you have to do is get on the right side of history and side with the RNC."

The embattled now former chairman of the US VI GOP **specifically fingered Yob** as the **ringleader** of a **band of amoral thugs** hired to **take out a properly elected state chairman** who was widely **supported by the elected delegates** AND **federal courts**, to wit: "Extortion has no place in our society and in our great party. Since 2016, Yob, Ackley, and others have actively sought to remove [me] from [my chairmanship] and replace me with operatives from other jurisdictions. Historically [they] have resorted to cheap tricks and dirty backroom politics."

**John Yob is a John McCain, Liz Cheeney type of Republican.** Yob started the fight in the USVI specifically to get position as a delegate to the 2016 RNC Convention **so he could be a Never-Trumper there.** A March 10, 2016 mLive story explains John Yob's motivations at that time:

Election officials revoked his registration last week, however, alleging that he falsified how long he has lived in the Virgin Islands in order to meet a 90-day requirement. Yob contends that a Republican National committeewoman is using her influence to impose a misinterpretation of the law.

People who live in the Virgin Islands cannot vote in presidential elections, but GOP rules allow registered Republicans to send nine delegates to the national convention scheduled in July in Cleveland. The delegation could play a pivotal role if neither Donald Trump nor any other Republican presidential candidate wins enough delegates to secure the party's nomination to the White House in advance of the convention.


If Yob becomes an unaffiliated delegate, his political support could be a valuable commodity to GOP candidates jockeying for the party's presidential nomination.

Yob's political career in Michigan has included helping Gov. Rick Snyder win election twice. He's also been involved in U.S. Senate campaigns for Terri Lynn Land and Pete Hoekstra. The strategist works extensively across the country.

Yob's use of dirty tricks in Michigan as part of his planned take down of Kristina Karamo was on continued display this week. As I have stated previously, self-proclaimed "journalist" Craig Mauger continues to be an errand boy for big government types regardless of political label preference. 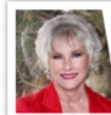

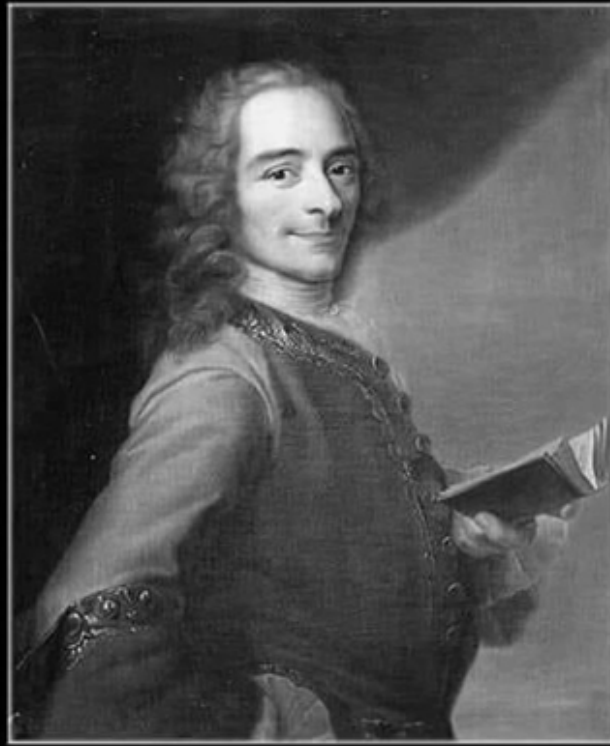
