Woot! Woot! Get on the Kari Lake train!

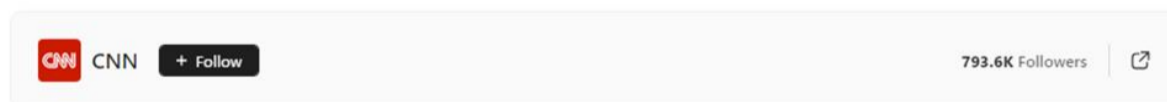
Some may be confused by recent headlines about Kari Lake and her exposure of election fraud in Arizona. Headlines like this one:

Kari Lake declines to defend her statements in a defamation case

Here is the back story:

In the aftermath of the 2022 election, Kari Lake exposed the political machine in both parties that were responsible for the theft of the election. In particular, she took aim at Republican election officials in Maricopa County, specifically including Steven Richer. Richer hired an establishment linked law firm (sound familiar, Michigan?) and sued on the claim that Lake's comments hurt his professional life and harmed his reputation.

After a kangaroo court of globalist bootlickers ignored two hundred plus years of legal precedent on political speech to say that the case could proceed to trial, Kari Lake pulled out a wildcard and refused to defend.

Why would she do this?

Kari lake understands this is war and she is acting in accordance with that. She will not try to fight on the enemy's prepared killing ground and instead will take the fight to her globalist enemies on her own terms and in her own way.

The Court system is severely compromised. It has been for a long time but we are seeing more and more evidence of it now. The reality is that Judge's are easily purchased and/or persuaded and I have seen that play out too many times to count. Here in Michigan we just saw that go down with the Michigan Republican Party being diced apart by a establishment law firm and a corrupt judge that was openly on the take from interested parties in the litigation.

Kari Lake chose to take the fight to the court of public opinion instead. A court that she dominates and cannot be so controlled. This decision significantly reduces the amount of time they can use the process to keep her off the campaign trail and sets her up for an appeal on the basis that political speech cannot be the subject of civil defamation cases.

Lawfare is a serious problem and requires us to have a great deal of discernment in the process of supporting political leaders. In many respects this reminds me of lessons we can learn from scripture: discernment in taking proper action is critical.

In particular, I reference Judges Chapter 7:

And the Lord said to Gideon, “The people who are with you are too many for Me to hand Midian over to them, otherwise Israel would become boastful, saying, ‘My own power has saved me.’ Now therefore come, proclaim in the hearing of the people, saying, ‘Whoever is afraid and worried, is to return and leave Mount Gilead.’” So twenty-two thousand from the people returned, but ten thousand remained.

Then the Lord said to Gideon, “The people are still too many; bring them down to the water and I will test them for you there. So it shall be that he of whom I say to you, ‘This one shall go with you,’ he shall go with you; but everyone of whom I say to you, ‘This one shall not go with you,’ he shall not go.” So he brought the people down to the water. Then the Lord said to Gideon, “You shall put everyone who laps the water with his tongue as a dog laps in one group, and everyone who kneels down to drink *in another*.” Now the number of those who lapped, putting their hand to their mouth, was three hundred men; but all the rest of the people kneeled down to drink water. And the Lord said to Gideon, “I will save you with the three hundred men who lapped, and will hand the Midianites over to you; so have all the *other* people go, each man to his home.”



Only those men that displayed proper discernment, decorum and discipline had the honor to remain as part of God's army with Gideon.

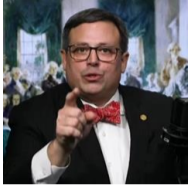
