## BEWARE OF FRAUDULENT CREDENTIALS

When you go to vote this Tuesday, February 27th, in the REPUBLICAN Presidential Primary, be very vigilant of the credentials that poll watchers and/or challengers are displaying.

Individuals displaying credentials signed by Kristina Karamo are not authorized to act in that role in the polling place and you should immediately call 911 if you see fraudulent credentials.

Per the Michigan Republican State Committee and Republican National Committee, Kristina Karamo is no longer the chair of the Michigan Republican Party and has no authority to issue credentials. Further, individuals bearing credentials with her signature may be bad actors seeking to disenfranchise voters supporting President Donald J. Trump.
